GM KLANG CULTURAL DANCE COMPETITION 2018 TERMS AND CONDITIONS

1.	Organizer	GAMUDA GM KLANG SDN BHD A-G-002, Ground Floor, Block A, GM Klang Wholesale City, Jalan Kasuarina 1, Bandar Botanic Capital, 41200 Klang, Selangor.
2.	Name of Competition	GM Klang The Cultural Dance Competition 2018 (GM Klang CDC)
3.	Competition Date	Saturday, 24 th February 2018
4.	Music Duration	A minimum of 3 minutes and not exceeding more than 5 minutes.
5.	Deposit	A fully refundable deposit of RM100 per group is required as security deposit. In the event of withdrawal/cancellation, the deposit will be fully forfeited and no refund will be allowed.
6.	Eligibility Criteria	<p>For the dance group to be eligible for the competition, the group must submit the following:</p> <ol style="list-style-type: none"> The completed registration form; Parent's consent form for each and every participant below the age of 18 years; and Video Audition submission with minimally 1 minutes recording. <p>A maximum of 12 dance groups will be shortlisted for the competition. An acknowledgment email from the organizer will be sent to the dance group within 5 working day to confirm if the group has been successfully shortlisted for the competition.</p> <p>The competition is open to all Malaysians citizens aged 13 years old and above. All participants below 18 years old are required to submit the registration form together with the consent of the person with parental authority. If the consent of the person with parental authority is not obtained, the registration will be considered as incomplete or invalid. The organizer shall be entitled to request to sight the original identity card or the originals of other supporting documents/ materials for verification process.</p> <p>Each dance group must have a minimum of two (2) members and a maximum of twelve (12) members.</p> <p>Employees of GM Klang Wholesale City Management Office and immediate family or associates of the Appointed Judges are not eligible to join the competition.</p> <p>Songs can be either traditional or with modern arrangement and in any language, as long as the dance style/origin and costumes are traditional/cultural with Chinese culture element. Dance styles of any folk dance or cultural origin with Chinese culture element (e.g. Malay, Chinese, Indian, Iban, Kadazan, etc.) are allowed. Vulgar or offensive lyrics or dance movements are strictly prohibited</p> <p>All participants must be present at the competition registration counter at GM Klang Wholesale City at 12pm on 24 February 2018. If the group is not present at the competition registration counter on 24 February 2018, the group's absence would be consider as a withdrawal, and the deposit paid will be deemed forfeited.</p> <p>Participants agree that the Organizer has the right to carry out photo and video shooting of the competition as promotional use or any other uses.</p> <p>The Organizer reserves full right to reschedule, change/modify the details of Competition such as date, venue, terms and condition and/or other related info to the competition at any time at its sole discretion.</p>
7.	Judging Criteria	<ol style="list-style-type: none"> Dance Origin, Technique & Execution (50%) Choreography, Routine & Patterns (30%) Entertainment Value (10%) Costume (10%)
8.	Application Process	<p>Each dance group must submit the following to the Organizer via email at hoky@gmum.com.my before 5pm, 24 January 2018:</p> <ol style="list-style-type: none"> The completed registration form; Parent's consent form for each and every participant below the age of 18 years; and Video Audition submission are required with minimally 1 minutes recording. <p>Groups shortlisted will be notified by an acknowledgment email from the organizer sent to the dance group within 5 working day to confirm if the group has been successfully registered for the competition.</p> <p>Dance group who have been shortlisted, payment of RM100 deposit shall be bank in and provide to Organizer within 3 working days from the email notification.</p> <p>Each shortlisted dance group must provide the music that will be used to the Organizer before 15th February 2018.</p>
9.	Entry Deadline	<p>The registration will be closed automatically by 5pm, 24 January 2018 or when a maximum of 12 dance groups have been successfully shortlisted, whichever occurs first. Entries received after the stipulated time will be disqualified and ineligible for participation for competition.</p> <p>Organizer reserves all right to verify the eligibility of all participants.</p>
10.	Additional Terms, if any	<p>Transportation and accommodation cost incurred in relation to and/or with respect to the Competition as a result of and/or pursuant to his/her participation in the Competition shall be borne by the participant.</p> <p>The judge's decision on all matters related to the competition is final. The winner and participants must not protest against the final result and will not make any comments about it or offer any personal opinion via any medium.</p> <p>Dance costumes should not be too revealing. Skirt or dress worn must cover the knees at all times for the girls. If the movements require high lifts of the legs, appropriate garments must be worn underneath the skirt, such as tights or leggings. Undergarments must not be seen at all throughout the entire dance routine. If seen, marks will be deducted.</p> <p>Accessories and props are allowed, but should not be inappropriate or dangerous such that it interferes with the dancing. Participant must check with organizer whether their props are allowed to be on stage.</p> <p>All prizes are strictly not transferable, assignable exchangeable or redeemable by the participant in any other form or manner other than that specified by the Organizer.</p>
